their manager and or group leader (hereinafter referred to as the "Artist"), and City of Vicksburg/Rossevelt Brown
(hereinafter referred to as the "Employer").

WITNESSETH: That for the personal services of the artist and subject to the terms and conditions hereafter set forth. Employer employs said Artist and Artist accepts such employment. The purpose, terms and conditions of the contract are as follows.

The agreement of Artist to perform is subject to death, serious illness, fire, accidents, unexpected mechanical delays, riots, strikes, any act of a public authority, Acts of God or other unforeseeable events which are beyond the control of the Artists. In such event, the deposit paid Artist by Employer will be immediately refunded to the Employer. Otherwise deposits are not refunded.

Employer and Artist further agree that this contract is not subject to cancellation unless both parties hereto have agreed to such cancellation and written notice of cancellation is delivered to the office of Frasco Entertainment America, in Flora, Mississippi at least ten (10) days prior to the date of the engagement stated herein. Deposits are not refunded.

For the true faithful performance of every covenant and agreement herein mentioned, the Employer and Artist bind themselves each unto the other in the penal sum of the amount set forth above as "Wages Agreed Upon" as liquidated damages to be paid by the failing party in addition to any costs, legal fees or attorneys fees incurred in the collection of such sum. Employer assumes full liability for any and all damages caused by guest, employee, members of Employer's organization of Employer to the instruments or equipment of Artist.

This instrument contains the entire agreement between the parties and that no statement, promise, or inducements made by any party hereto or agent or representative of either party hereto, which is not contained in this written contract, shall be valid or binding and this contract shall not be enlarged, modified or altered except in writing signed by the parties hereto.

It is understood and agreed by the Employer and Artist that Frasco Entertainment America, is not a party of this contract and that its only function is that of an entertainment bureau (booking agency, and, further, that Frasco Entertainment America, is not responsible to either party for breach of this contract by either party. Frasco Entertainment America, Inc. will assist and aid in arbitration or settlement of any breach providing both parties are willing to arbitrate in good faith.

The City of Canton, Madison County, Mississippi shall have venue of any action arising out of this contract; and, the interpretation and legal effect of this contract shall be governed by the laws of the State of Mississippi.

By executing this contract as Employer the person executing said contract either individually or as an agent or representative of the employing organization, represents and warrants that he or she is twenty-one years of age, and, further, that he or she has the authority to enter in to this contract and should he or she not have such authority, he or she personally accepts and assumes full responsibility and liability under the terms of this contract. In the event it becomes necessary for Artist to employ an attorney for collection of the wages due herein Employer agrees to pay Artist a reasonable attorney's fee.

Employer and Artist agree that should Artist accept employment again from Employer within twelve (12) months next following date of the engagement herein, negotiations for such replay date will be conducted through Frasco Entertainment America and Artist agrees to pay Frasco Entertainment America its usual commission from such replay date.

EMPLOYER AGREES AND UNDERSTANDS THAT THE PLACE OF THE ENGAGEMENT HEREIN WILL BE INDOORS UNLESS SPECIFICALLY AGREED TO OTHERWISE BY ARTIST.
