(a) For General Revenue purposes and for General Improvements including the following: Supervision and Finance; Protection of Life and Property; of Police and Fire Departments; Care and Maintenance of Public Property; Maintenance of Streets and Structures; Public Health and Sanitation; Instruction and Recreation; and other Miscellaneous Expenditures as fixed and limited by House Bill No. 77 of the Laws of 1950, as amended
