TAX LEVY FOR 2026

This being the month as provided by law for the Mayor and Aldermen of the City of Vicksburg to fix the tax levy of the City of Vicksburg, Mississippi for the year 2025, it is now ordered and adjudged that the following ad valorem tax rates or levies be and the same are hereby imposed and levied for the year 2025 upon the assessed value of all taxable property, Real, Personal and Public Service in the City of Vicksburg, State of Mississippi, upon the assessment rolls of the said City as of January 1, 2025, the said rates, expressed in mills, being levied and imposed upon each dollar of assessed valuation appearing upon the assessment rolls of the City of Vicksburg for the following funds or purpose:

Mills

(a) For General Revenue purposes and for General Improvements including the following: Supervision and Finance; Protection of Life and Property; of Police and Fire Departments; Care and Maintenance of Public Property; Maintenance of Streets and Structures; Public Health and Sanitation; Instruction and Recreation; and other Miscellaneous Expenditures as fixed and limited by House Bill No. 77 of the Laws of 1950, as amended	30.15
(b) For Municipal Bonds and Interest thereon	4.03
(c) Police and Firemen's Disability Relief Fund as authorized by House Bill No. 643, Chapter 287, of Laws of 1940 as amended	1.70

TOTAL CITY-WIDE MILLAGE RATE	35.88

It is further ordered and adjudged that the tax levy for fiscal year 2025-2026 for the Business Promotion Area be levied against the assessed value of the commercial real property within the boundaries as established for the area by resolution as adopted on September 15, 2025, as authorized by House Bill Number 1223, Chapter 890, Laws of 1984 be set at	5.05
