1. **Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless **City of Vicksburg, its Board of Mayor and Aldermen**, its successors and assigns, City employees, from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my volunteer work.
2. **Insurance:** I understand that **City of Vicksburg** does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance of any nature in the event of my injury, illness, death, or damage to my property.
3. **Medical Treatment:** I hereby release and forever discharge **City of Vicksburg** from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time as a volunteer.
4. I understand that participation in the above-named activities involves certain risks, including, but not limited to, serious injury, property damage and death. I am voluntarily participating in the volunteer activities with knowledge of the danger involved and I agree to accept all risks of participation.
5. Other: I expressly agree that this Release is intended to be as broad and inclusive as permitted by law. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.

By signing, I acknowledge that I have read and understood all of the terms of this Release and that I am voluntarily giving up substantial legal rights.
