Proposal to Contract Tree Removal at 1401 Lincoln Street

A city resident, located at 1401 Lincoln Street, has filed complaints that a tree located on city property has become a hazard to their home and property. I have attached pictures of the tree on pages 2 and 3 of this proposal. The tree is located on top of a hill and has limbs that hang over the residents' roof, power lines and driveway. The resident claims that they have already had to repair their shed due to limbs falling from the tree and is concerned that the limbs may cause damage to their home or vehicles if the issue is not addressed.

The city public works department does not have a bucket truck capable of getting high enough to cut the tree in a safe manner. There is also liability concerns with the tree being located above power lines and the residents' home.

With that being said, I have requested quotes from two separate tree service companies. I have attached copies of the quotes that I received on pages 4 and 5 of this proposal. Both companies said that they would likely have to send a climber up the tree to remove the tree in small enough pieces to prevent damage to the power lines and/or the residents' property. Both quotes also include the removal of all debris after the tree is cut. Of the two quotes, the lowest quote was \$10,000.

If granted the boards' approval, I would like to award the company who provided the lowest quote with a contract to cut the tree. (Fuentes Tree Service LLC)
