I am writing to request your approval for the reimbursement of \$250.00 to Ms. Angela Smith for a towing fee she incurred due to an error on the part of the Vicksburg Police Department.

On April 23, 2025, Ms. Smith's vehicle, a 1985 Pontiac Grand Prix, was parked in front of 1701 South Street which is across the street from her residence. While the vehicle was partially parked on the sidewalk and grass, the proper departmental procedure of placing a tow warning sticker to allow the owner time to move the vehicle was not followed.
