That Mayor Willis Thompson be authorized to execute the *Joinder and Waiver* agreeing to join in the request for relief contained in the *Petition to Waive Accounting, Close Estate, Distribute Assets and Discharge Executor* and that the City Attorney be authorized to file the *Joinder and Waiver* with the Warren County Chancery Clerk's Office on behalf of the City of Vicksburg, a copy of the Joinder and Waiver is attached as Exhibit C; and
- 2. That the City be authorized to accept the donation of \$2,000.00 from the Estate of Madgalene Frances Brown with the donated funds being appropriated to the City of Vicksburg's Senior Center; and
- 3. That the Senior Center shall be authorized to use the donated funds to continue providing services that promote wellness, independence, self-worth, and an overall positive image of aging citizens.
