SUPPLEMENTAL AGREEMENT NO. 2

THIS SUPPLEMENTAL AGREEMENT made and entered into by and between the **UNITED STATES OF AMERICA**, hereinafter referred to as the "Government," and, **CITY OF VICKSBURG, MISSISSIPPI**, hereinafter referred to as the "Grantee".

WITNESSETH THAT:

WHEREAS, on 21 November 2023, the Government and the City of Vicksburg, Mississippi entered into a license agreement for the construction, operation, and maintaining of a parking area, sidewalk with handrails, and lighting located in downtown Vicksburg, Mississippi designated as Contract No. DACW38-3-23-87, hereinafter referred to as the "Original License," for a term of five (5) years beginning 1 June 2023 and ending 31 May 2028, located in Section 19, Township 16 North, Range 3 East, in Warren County, Mississippi; and

WHEREAS, by way of Supplemental Agreement No. 1, the City of Vicksburg requested to upgrade their existing structures by installing new benches, shade structures, and other landscape features; and

WHEREAS, by way of Supplemental Agreement No. 1, Aaron Posner is now the new point of contact for this License, replacing Jonathan Harrell and should be contacted concerning this project; and

WHEREAS, Contract No. DACW38-3-22-32, a license agreement for the construction, operation, and maintenance of a staircase located at the Lower Mississippi River Museum, Vicksburg, Mississippi, is expiring on 31 March 2026, and the City of Vicksburg has requested this license be included with license Contract No. DACW38-3-23-87; and

WHEREAS, it is considered in the best interest of the Government to allow this modification; and,

NOW THEREFORE, in consideration of the premises, the party hereto does hereby amend the original license in the following respects and in these respects only:

THAT the language in the first paragraph of the "Original License" read "a license to access Government lands to construct, operate, and maintain a staircase, parking area, sidewalk with handrail, lighting, and landscape features located in downtown Vicksburg, Mississippi".

THAT a Special Condition clause be added to this license as Condition No. 21 which states, "Prior to any commencement of new construction, notify Mr. Aaron Posner of the U.S. Army Corps of Engineers Vicksburg District Operations Division at (601) 631-5287 or Mr. Dylan Wooten of the Real Estate Division at (601) 631-5975."

THAT this Supplemental Agreement No. 2 is effective upon execution of the Real Estate Contracting Officer.

THAT all other terms and conditions of said license shall remain in effect.

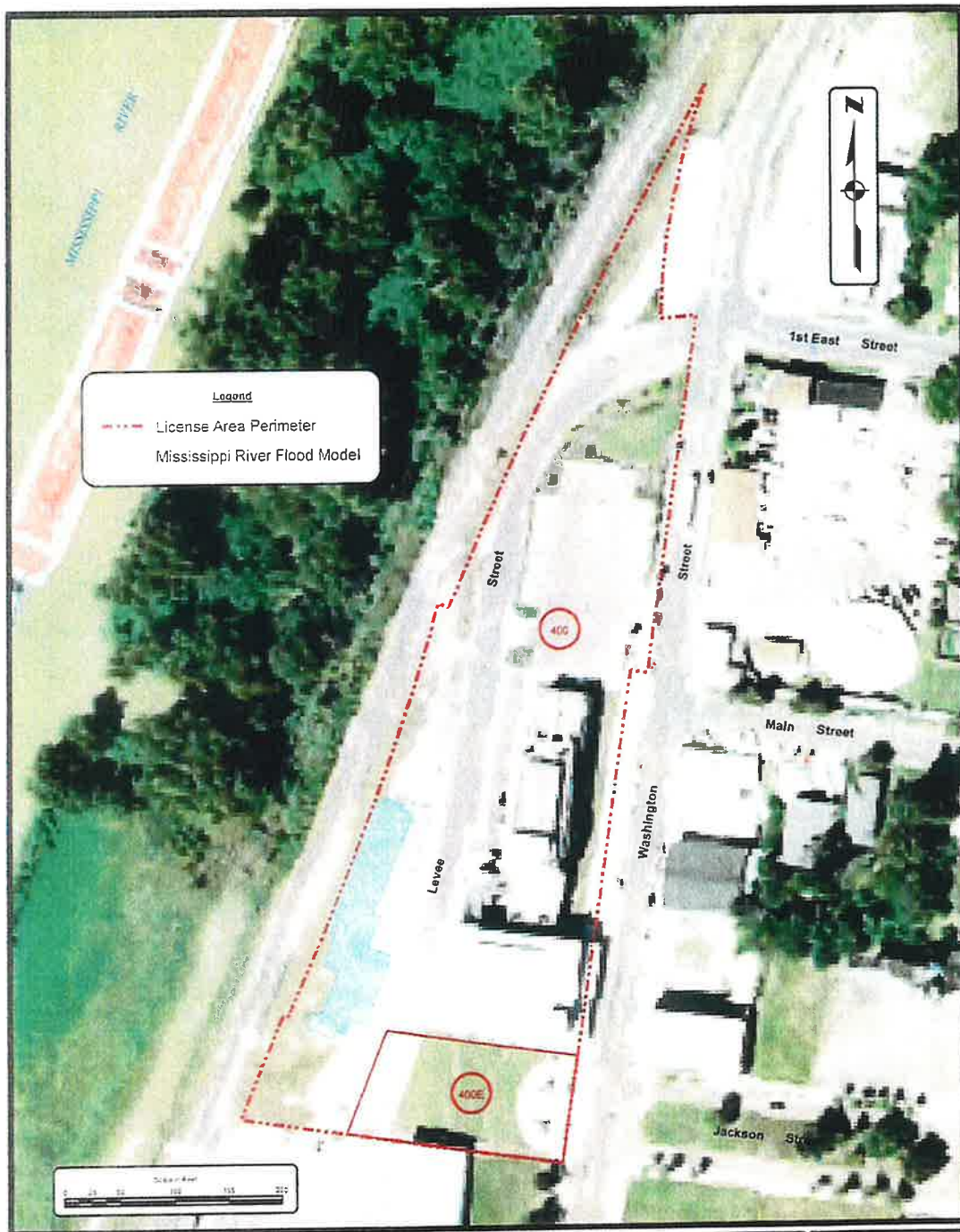
