Dear Board of Mayor and Alderman/Alderwoman:

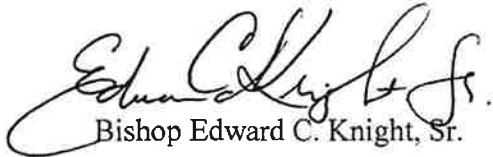
