RESOLUTION TO SUBMIT AN APPLICATION FOR THE CITY OF VICKSBURG TO HAVE CERTAIN PROPERTY DESIGNATED AS A QUALIFIED RESORT AREA AS DEFINED BY THE RULES AND REGULATIONS OF THE ALCOHOLIC BEVERAGE CONTROL DIVISION OF THE MISSISSIPPI DEPARTMENT OF REVENUE

WHEREAS, the City of Vicksburg, Mississippi, a special charter municipality existing under the laws of the State of Mississippi, regularly attracts a substantial number of vacationers, travelers, and tourists to its municipality;

WHEREAS, Vicksburg, Mississippi, replete with historical attractions and Southern culture, depends heavily on tourism; and

WHEREAS, the Duff Green Mansion is located at 1114 First East Street, Vicksburg, Mississippi and is a restored antebellum home in the heart of the historic Vicksburg, Mississippi and is a popular destination housing around 4,000 overnight guests annually; and

WHEREAS, Rule 35.113.07 of the Rules and Regulations of the Alcoholic Beverage Control Division of the Mississippi Department of Revenue allows for an area to be considered for qualified resort area classification by submitting an application in accordance with said regulation.

NOW, THEREFORE, BE IS RESOLVED by the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi as follows:

- 1. The City of Vicksburg hereby requests the Alcoholic Beverage Control Division of the Mississippi Department of Revenue designate as a qualified resort area that parcel of property located at 1114 First East Street known as the Duff Green Mansion owned by Harley H. Caldwell as more fully described in the Exhibit "A" attached to this Resolution and made a part hereof.
- 2. That the Mississippi Department of Revenue is hereby assured that the local law enforcement officers will enforce the local option alcohol beverage control laws of the State of Mississippi and the rules and regulations of the Alcohol Beverage Control Division as indicated by the letter from Vicksburg Police Department Chief Larry Burns attached as Exhibit "B".

- 3. That Harley H. Caldwell published notice of application once each week for two (2) consecutive weeks in the Vicksburg Post, a newspaper published and having general circulation in the City of Vicksburg, Mississippi, and she requested public opinion from residents within the qualified resort area under consideration as a part of that legal notice, see Proof of Publication and Public Notice attached as Exhibit "C".
- 4. That the City of Vicksburg be and is hereby authorized and directed to submit an application to the Alcoholic Beverage Control Division of the Mississippi Department of Revenue to classify the above-described property in the City of Vicksburg as a qualified resort area. The application is to contain the following:
 - a. A map clearly marked to indicate the specific area under consideration, attached as Exhibit
 "D";
 - Reasons why the particular area should be classified as a qualified resort area, attached as Exhibit "E";
 - c. Endorsements by civic clubs in the area, attached as Exhibit "F";
 - d. Assurance from the Vicksburg Chief of Police that he will enforce the local option alcoholic beverage control laws of the State of Mississippi, and the rules and regulations of the Alcoholic Beverage Control Division in the qualified resort area, attached as Exhibit "B";
 - e. A certified copy of this Resolution as entered upon the minute books;
 - f. Waiver of Minimum Distance Requirements by a Church or Funeral Home, attached as Exhibit "G"; and
 - g. Proof of publication of legal notice and all public opinion responses, attached as Exhibit "C".SO RESOLVED this the 17th day of November, 2025.



Why Should The Duff Green Mansion Be Considered for Resort Status

Section 35 of the Mississippi Code states an area granted resort status should regularly attract tourists, transients and/or vacationers because of its historical, scenic or recreational facilities and attractions.

The Duff Green Mansion rents approximately 2,300 hotel rooms per year just at the Mansion located at 1114 First East Street. The Caldwells rent approximately one thousand more rooms per year at two other facilities, Halpino and Steele Cottage. Rooms/Suites sleep between 2 people and 8 people. Halpino and Steele Cottage guests are invited to come for a welcome reception, breakfast and tour of Duff Green Mansion and to swim at Duff Green pool. Approximately 3,500 people per year come through Duff because of our overnight accommodations.

The Duff Green Mansion also gives tours predominantly to guests from the American Cruise Lines. Approximately another 3,500 people per year come for a tour.

The Duff Green Mansion attracts tourists and vacationers.

The management team of Rick and Harley Caldwell do not intend to open a restaurant under any circumstances. However, we would like to sell liquor to the over 7,500 people coming through our doors annually. To sell liquor without significant food in Mississippi we must be designated as a qualified resort.

The Duff Green Mansion is listed on the National Register of Historic Places. It's history is rich.

A man named Duff Green built the home for his bride, Mary Lake, in 1856 just seven years before the siege of Vicksburg.

Our tour for visitors starts with a description of life during the Victorian Era here in the south and moves on to describe how Duff saved his home during the civil war siege of Vicksburg. He turned it into a hospital for both Union and Confederate wounded but more importantly was somehow able to get word to the Union officers that the Union wounded were housed on the top floor. The shelling of the area slowed considerably. There are more surviving historic properties in a six-block radius around the Mansion than any other place in town. Duff saved his neighborhood.

We continue with a description of the Green's son named Siege because he was born in a cave as the town was being plummeted with cannon balls. Our tour attempts to be truthful in explaining that Duff did indeed own slaves, the context of that time and the details we are currently researching about the slaves living in the home before the war.

We go on to explain that Duff was the first non-military person in Warren County to sign the oath of allegiance to the United States of America on July 4, 1863, the day of the Vicksburg surrender to the Union. We explain that Duff was not very loyal to the Confederacy. He was an opportunist. He signed first because he had already rented his home to the federal government. It took 3 years to get all the wounded well and home. The US government did not pay in Confederate Dollars. Duff earned US dollars through this rental two years before the Confederacy fell. Duff was an opportunist more than a Confederate.

We finish our tour talking about the demise of the Green family. The children all died before marrying and having children. Their story would be lost if the house had not survived.

The first stewards of the house were Junius Ward Johnson and his wife Fannie Vick Willis Johnson. They lived there for a few years while they built two identical mansions, Oak Hall, newly restored on Drummond Street and another home at Panther Burn, MS. Mr. Johnson was killed in a 1916 tornado that took him, and the Panther Burn home. Mrs. Johnson sold that farm for one million Dollars in 1916 and became the biggest philanthropist Vicksburg ever had. When she died in 1931 her estate sold the home now known as The Duff Green Mansion to the Salvation Army for \$ 3,000. They got their money's worth. They stayed for 54 years and didn't do much maintenance on the house but they kept it standing at a time when there was no historic preservation in MS. There wasn't any money in Mississippi after the depression.

The Salvation Army sold the home in 1985 to Harry and Alicia Sharp who moved here from Coral Gables, Florida to spend two million dollars and two and a half years having the home restored. The Sharps sold to the Caldwells in 2015.

We finish the tour by telling our visitors that keeping Duff and Mary Green's story alive is not just important to our family it is important to the entire tourism community of Vicksburg. We thank them for visiting Vicksburg.

Boasting a swimming pool and rose garden The Duff Green Mansion is not only historical, it is recreational.

The Sharps had a liquor license because they had a restaurant. The Caldwells are too old to run a restaurant. Today we ask the mayor and alderpersons of Vicksburg to petition the State of Mississippi to formally declare The Duff Green Mansion the resort that it is.
