

**A RESOLUTION TO APPROVE THE TEMPORARY CLOSURE OF MUNICIPAL
STREETS FOR MAINTENANCE OF THE PARKING GARAGE LOCATED AT 1500
WALNUT STREET, VICKSBURG, MISSISSIPPI**

WHEREAS, Miss. Code Ann. 21-19-15 provides that "[t]he governing authorities of municipalities shall have power to make all needful police regulations necessary for the preservation of good order and peace of the municipality and to prevent injury to, destruction of, or interference with public or private property"; and

WHEREAS, pursuant to Miss. Code Ann. 21-19-15, the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi ("Board") can temporarily close municipal streets for public purposes to preserve "good order" and prevent damage to public or private property, so long as there are alternative means of ingress and egress to the affected areas are available to the public; and

WHEREAS, Building and Maintenance Director Eddie Sanders requests that, from May 18, 2026 through May 24, 2026, the parking garage located at 1500 Walnut Street, Vicksburg, Mississippi be closed for a deep cleaning which will involve the use of strong chemicals that could be potentially hazardous to the public and cause damage to personal property; and

WHEREAS, Director Sanders further requests that the neighboring streets surrounding the parking garage, more specifically from the intersection of Veto Street to Walnut Street to the intersection of South Street and Walnut Street to the intersection of Washington Street and South Street as indicated on the map attached as Exhibit A, be closed to the public and blocked off and barricaded to prevent damage to public and private property; and

WHEREAS, Director Sanders requests to obtain and place signage to properly block off the parking garage and temporarily close off the requested streets and that the Director of Information Technology notify the public through the City of Vicksburg alerts of the streets closure and garage closure for the requested dates; and

WHEREAS, the Board of Mayor and Aldermen are of the opinion that the closing of the parking garage located at 1500 Walnut Street, Vicksburg, Mississippi 39180 is in the best interest of the City to preserve good order and prevent damage to public or private property and that alternative means of ingress/egress to the affected areas are available to the public.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF VICKSBURG, MISSISSIPPI, AS FOLLOWS:

SECTION 1. That the matters, facts, and things recited in the Preamble hereto are hereby adopted as the official findings of the Governing Authority.

SECTION 2. That the portion of streets identified in Exhibit "A" hereto and the parking garage located at 1500 Walnut Street, Vicksburg, Mississippi shall be closed beginning May 18, 2026 through May 24, 2026 (or for other city approved date/times as may be required due if necessary due to the cleaning of the parking garage due to weather or other unforeseen circumstances), including to parked and traveling vehicles and pedestrians, to preserve "good order" and to prevent damage to public or private property and that alternative means of ingress/egress to the affected areas shall be made available to the public.

SECTION 3. That Building and Maintenance Director Eddie Sanders obtain the necessary signage to notify the public about the parking garage and streets closure so that an alternative means of ingress/egress to the affected areas is made available.

SECTION 4. That the Director of Information Technology Adrian Reddix and his Department send out alerts to notify the public about the streets and garage closure prior to closing.
