

**A RESOLUTION AUTHORIZING MAYOR WILLIS THOMPSON'S EXECUTION OF
PROGRESSIVE INSURANCE FULL RELEASE OF ALL CLAIMS WITH INDEMNITY**

WHEREAS, on July 31, 2026, Mayor Willis Thompson of the City of Vicksburg, Mississippi executed a **Full Release of All Claims with Indemnity** releasing, acquitting, and forever discharging Progressive Northern Insurance Company ("Progressive"), Nicholas Fadero, agents, employees, principals, employers, insurers, heirs, executors, administrators, successors and assigns of and from any and all claims, actions, causes of actions, demands, and rights, including, but not limited to claims for damages, costs, towing and storage costs, loss of use or opportunity, property damage, expenses, loss of profits accrued or unaccrued claims, other known and unknown damages relating to property damaged or destroyed, which heretofore have or which hereafter may be sustained by me (us) in consequence of any claim that may occur, may have occurred, or would ever be alleged to have occurred in the automobile collision on or about 04/14/2026 at or near Vicksburg, Mississippi; and

WHEREAS, Progressive requests a resolution authorizing Mayor Willis Thompson to execute documents on behalf of the City of Vicksburg, Mississippi ("City").

**NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN
OF THE CITY OF VICKSBURG THAT:**

Section 1. The above recitals are hereby incorporated as findings by the Board of Mayor and Aldermen of City of Vicksburg, Mississippi.

Section 2. Mayor Willis Thompson is hereby authorized on behalf of the City of Vicksburg, Mississippi to execute any and all necessary settlement agreements and documents to settle the City's pending claim against Progressive, Nicholas Fadero and other agents for property damage.
