

Contract of
Pyroman Fireworks 2, LLC

This agreement entered on May 18, 2026 by and between Pyroman Fireworks 2, LLC party of the first part and City of Vicksburg, MS party of the second part.

Pyroman Fireworks 2, LLC agrees to display for City of Vicksburg, MS on July 4, 2026 in a location designated by City of Vicksburg, MS and approved by Pyroman Fireworks 2, LLC one exhibition of fireworks, in accordance with the program that was mutually agreed upon. We reserve the right to make substitutions of equal or greater value as long as it does not reduce the value of the program that was agreed upon. The cost of this program is based on the value of the shells and effects and not on shell count. Pyroman Fireworks 2, LLC agrees to furnish sufficient labor to set up and shoot the fireworks.

City of Vicksburg, MS agrees to furnish the necessary police protection and crowd control at all times during the preparation of the exhibition and firing of same, and for at least a period of 30 minutes after the exhibition is fired. Pyroman Fireworks 2, LLC agrees to inspect the area the night of the display to safely remove and dispose of any unexploded shells or live components. Furthermore, City of Vicksburg, MS agrees to take responsibility for the cleanup of fallout debris that may remain on the property after the display. Pyroman Fireworks 2, LLC agrees to procure any and all necessary permits and license, which may be required by the municipal or state authorities. Pyroman Fireworks 2, LLC will do a post display inspection the night of the display and as soon as reasonably possible the next morning.

Pyroman Fireworks 2, LLC agrees to furnish insurance, Public Liability and Property damage in a General Aggregate amount of two Million Dollars to City of Vicksburg, MS.


Pyroman Fireworks 2, LLC agrees that in the event of rain or inclement weather, a postponement may be made to a date to be determined by both parties up until 10/31/2026. There will be a postponement fee, if the display has been delivered to the site of actual cost incurred. If City of Vicksburg, MS notifies us of a postponement prior to the display leaving our warehouse there will be an administration fee for cost incurred. In the event of total cancellation before set up, City of Vicksburg, MS agrees to pay 50% of the contract price plus expenses incurred. It is also understood and agreed by the parties hereto that in the event the fireworks have been taken out and set up before any rain then such exhibition of fireworks must be carried out in the best possible manner without any deductions whatever from the hereafter named compensation.

Pyroman Fireworks 2, LLC shall not incur any liability for any loss or for any failure to perform any obligation hereunder due to causes beyond its control without limitation to legal or regulatory restrictions.

City of Vicksburg, MS agrees to pay the total contract price of \$46,000.00 be paid to Pyroman Fireworks 2, LLC prior to or on the day the exhibition is performed.

The fireworks program will have a duration of approximately 30 minutes
