

**RESOLUTION AUTHORIZING MATCHING FUNDS
FOR THE 2025 COMMUNITY INFRASTRUCTURE FUND THROUGH
THE DELTA REGIONAL AUTHORITY**

WHEREAS, the City of Vicksburg submitted an application to the Delta Regional Authority for the Community Infrastructure Fund On August 30, 2025; and

WHEREAS, funding is available for road work that would assist with north Washington Street from Haining Road to the US 61 North corridor, along with the Port of Vicksburg; and

WHEREAS, the Board of Mayor and Aldermen of the City of Vicksburg deemed it in the best interest of the City of Vicksburg to apply for said grant funding for infrastructure support and economic development; and

WHEREAS, the grant, if awarded, will fund up to \$2,000,0000 for the City of Vicksburg to further its work with the Port of Vicksburg and all businesses improving roads for the 14 million tons of freight that travel to and from Haining Road each year;

WHEREAS, the Board of Mayor and Aldermen of the City of Vicksburg deem it valuable and in the best interest of the City of Vicksburg to match these funds, if received, with \$200,000.00;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Mayor and Aldermen of the City of Vicksburg hereby authorized and directed Lucy DeRossette to make proper application to the Delta Regional Authority for the 2025 Community Infrastructure Fund and are prepared to match these funds with \$200,000 if awarded.

FURTHER, BE IT RESOLVED that:

1. The Board of Mayor and Aldermen of the City of Vicksburg, Mississippi, be authorized to expend up to \$200,000.00 on this project if Delta Regional Authority funds are awarded; and
