

**RESOLUTION AUTHORIZING PREPARATION AND SUBMITTAL  
OF AN APPLICATION TO THE  
USDA NATURAL RESOURCES CONSERVATION SERVICE**

**WHEREAS**, the Board of Mayor and Aldermen of the City of Vicksburg (hereinafter "Board") is eligible to submit an application for federal assistance SF-424 to the USDA Natural Resources Conservation Service for road and bank stabilization for the following locations in the City of Vicksburg: Hennessey, Old Hwy 80, Pittman Avenue and Confederate Avenue.

**WHEREAS**, the Board deems it in the best interest of the citizens of Vicksburg for the application to be submitted to the USDA Natural Resources Conservation Service for the stabilization of the bank and roads for the following locations in the City of Vicksburg: Hennessey, Old Hwy 80, Pittman Avenue and Confederate Avenue.

**NOW, THEREFORE, BE IT RESOLVED**, that the City of Vicksburg, by and through its authorized representative, is hereby authorized and directed to make a proper application to the USDA Natural Resources Conservation Service for federal assistance for road and bank stabilization.

**FURTHER, BE IT RESOLVED** that:

1. The Board of Mayor and Aldermen of the City of Vicksburg authorize Nicole Grafton, City's Grants Administrator, as the official designee and applicant's agent, and authorize her to submit the application for federal assistance SF-424 to the USDA Natural Resources Conservation Service; and
2. The Board be authorized to accept any funds received from the USDA Natural Resources Conservation Service for the stabilization of the bank and roads for the following locations in the City of Vicksburg: Hennessey, Old Hwy 80, Pittman Avenue and Confederate Avenue; and
3. The Board hereby authorizes Mayor Willis Thompson to execute the Application for Federal Assistance SF-424, the Assurances-Construction Programs and the Certification Regarding Lobbying; and
4. The Board further authorizes Mayor Willis Thompson to execute any agreements and other documents that may be of necessity be executed in the implementation of this program.
