

**RESOLUTION TO ACCEPT DONATION OF A SCULPTURE DONATED TO THE WASHINGTON STREET PARK BY LEVITT AMP MUSIC SERIES PROGRAM**

**WHEREAS**, the Mississippi Arts Commission, Visit Mississippi, Mississippi Main Street Association, the Levitt Foundation, the Maddox Foundation, the Heritage Guild of Vicksburg and Warren County, and the National Endowment for the Arts provide grants to build communities through music to create a healthy and thriving future for everyone; and

**WHEREAS**, the grant opportunities provide grant recipients with valuable resources to deepen impact in their communities; and

**WHEREAS**, the City of Vicksburg received a three (3) year grant, valued up to \$120,000, from the Levitt Family Foundation to host the Levitt AMP Vicksburg music series, which includes 7 - 10 free, family friendly live concerts at the Washington Street Park; and

**WHEREAS**, the Levitt AMP Vicksburg Music Series co-organizers initiated the creation of a sculpture that they desire to be installed at Washington Street Park located at 1007 Washington Street, Vicksburg, Mississippi 39180, picture of sculpture attached as Exhibit A; and

**WHEREAS**, the City finds that such a donation of the sculpture to Washington Street Park (once completed) is acceptable.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi that the Board hereby accepts the donation of the sculpture, once construction is completed, from the Mississippi Arts Commission, Visit Mississippi, Mississippi Main Street Association, the Levitt Foundation, the Maddox Foundation, the Heritage Guild of Vicksburg and Warren County, and the National Endowment for the Arts to become a part of the City of Vicksburg's inventory and that the Levitt AMP Vicksburg Music Series is authorized to have the sculpture installed at the Washington Street Park.
