RESOLUTION TO WAIVE WATER AND GAS UTILITY DEPOSIT AND SERVICE CHARGES ASSESSED TO SALVATION ARMY

WHEREAS, Mississippi Code Annotated Section 21-27-27 authorizes the governing authorities of a municipality to furnish utility services, free of charge, to any benevolent institution located within the municipality; and

WHEREAS, the Salvation Army, a non-profit organization, annually helps Americans overcome poverty, addiction, and economic hardships through a range of social services. The organization provides food for the hungry, emergency relief for disaster survivors, rehabilitation for those suffering from drug and alcohol abuse, and clothing and shelter for people in need; and

WHEREAS, the local Salvation Army secured a building within the city limits of Vicksburg, Mississippi located at 4000 S Frontage Rd Space #B2, Vicksburg, MS 39180 for its Angel Tree program which provides gifts to children within the Vicksburg community for Christmas; and

WHEREAS, the Salvation Army is in need of water and gas services provided by the City of Vicksburg at the building; and

WHEREAS, The Board of Mayor and Aldermen of the City of Vicksburg (hereinafter "Board") hereby finds that the Salvation Army is a benevolent institution based on its charitable and philanthropic nature of providing services to people in need in the Vicksburg community; and

WHEREAS, the Board finds that the deposit and service charges for water and gas assessed to the Salvation Army's building secured for the placement of the Angel Tree will be waived during the duration of the time the building is used for the Angel Tree program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF VICKSBURG, MISSISSIPPI that the Salvation Army is hereby deemed a benevolent institution pursuant to Mississippi Code Annotated Section 21-27-27 based on its charitable and philanthropic natures; and

BE IT FURTHER RESOLVED that The Board of Mayor and Aldermen of the City of Vicksburg hereby waives the water and gas deposit and service charges assessed to the building located at 4000 S Frontage Rd Space #B2, Vicksburg, MS 39180 where the Angel Tree program will be held for the duration of the program pursuant to Mississippi Code Annotated Section 21-27-27.
