

**RESOLUTION FOR GRAND OPENING OF MYRLIE EVERS CIVIL RIGHTS PARK**

**WHEREAS**, on April 29, 2026, the City of Vicksburg will sponsor the grand opening of the Myrlie Evers Civil Rights Park located at 1598 Dr. Martin Luther Jr. Blvd to the public; and

**WHEREAS**, the Board of Mayor and Aldermen of the City of Vicksburg requests, to ensure public safety, that the portion of Dr. Martin Luther King Jr. Blvd as indicated on the attached map be closed, that first responders from the Vicksburg Police Department and Vicksburg Fire Department be present for emergency response and public safety; and

**WHEREAS**, the Board finds that it is appropriate for these measures to ensure public safety.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi the following:

- 1) That the Street Department will close the portion of Dr. Martin Luther King Jr. Blvd. on both sides of the Civil Rights Park to ensure the safety of any attendee at the Grand Opening.
- 2) That the Vicksburg Police Department and Vicksburg Fire Department will be present for emergency response and public safety.
- 3) The City Purchasing Department be authorized to purchase water bottles and provide fans for attendees of the event.

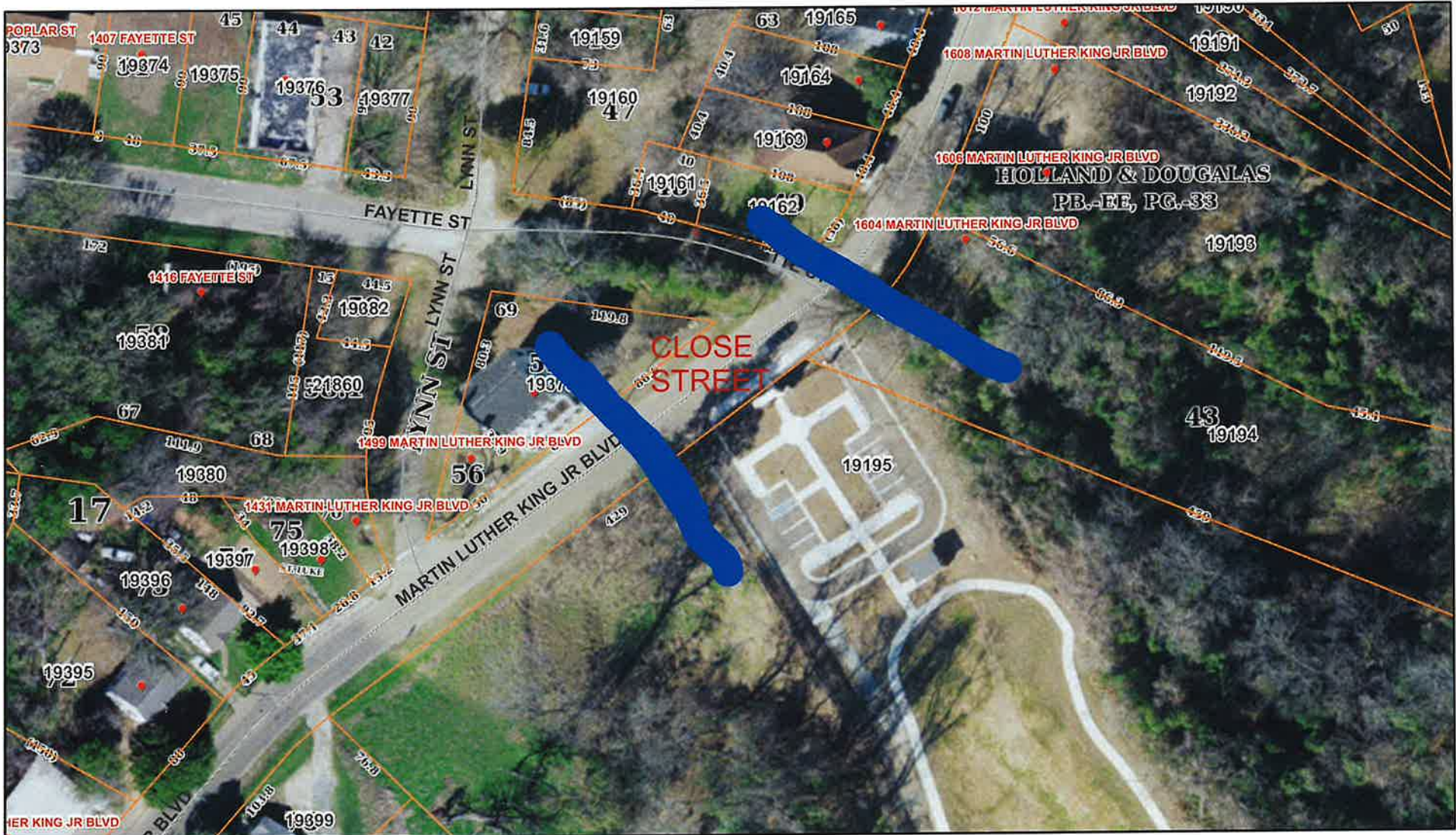
