Dear Board:

The Wellness Clinic and Health Care Program Committee reviewed the submitted proposals from medical providers desiring to serve as the City of Vicksburg's Wellness Clinic and Health Care Provider. The Committee evaluated each submitted proposal utilizing the following criteria: 1) Executive Summary of the Vendor's business plan; 2) Narrative of the Project outlining the proposed services; 3) Methodology proposing how the deliverables for the provision of services will be met; 4) Project Management providing how the clinic will be managed and; 5) Financial Reporting/Budget to determine if the proposed costs for operations aligns with City's budget.
