RESOLUTION BY THE MAYOR AND ALDERMEN OF THE CITY OF VICKSBURG, MISSISSIPPI TO DESIGNATE THE PROPER INDIVIDUALS TO SIGN CHECKS AND PERFORM BANKING TRANSACTIONS

WHEREAS, Section II of the City of Vicksburg Charter dictates the manner in which payments of warrants or checks shall be issued and,

WHEREAS, the Mayor and Aldermen whish to designate the proper officials to sign checks and perform banking transactions.

THEREFORE, BE IT RESOLVED, by the Mayor and Aldermen of the City of Vicksburg that:

- 1. All checks shall require two (2) signatures, one of which shall be the Mayor, Willis T. Thompson and the second which shall be the City Clerk, Deborah A. Kaiser-Nickson. In the absence of the Mayor, the Mayor Pro Tem, Vickie Y. Bailey, may sign in place of the Mayor and in the absence of the City Clerk, the _Director of Finance & Accounting, Doug Whittington __, may sign in the place of the City Clerk.
- 2. <u>Mayor, Willis T. Thompson</u> and the <u>City Clerk, Deborah A. Kaiser-Nickson</u>, each shall have access to the safety deposit boxes located in any bank which the City of Vicksburg may rent.
- 3. <u>Mayor, Willis T. Thompson</u> or <u>City Clerk, Deborah A. Kaiser-Nickson</u>, are designated the authority to accept or release securities pledged by financial institutions guaranteeing funds held for deposit for the City of Vicksburg.
- 4. The Mayor and Aldermen do hereby authorize the use of machines to produce facsimile signatures of the Mayor and City Clerk on all warrants or checks issued by the Clerk's Office in making payments dully authorized by the Board of Mayor and Aldermen.
