

**A RESOLUTION ACCEPTING AND RATIFYING THE CONSUMER PRICE INDEX
ADJUSTMENT OF BASE ANNUAL FEE FOR CONTRACT YEAR 11 OF THE SERVICES
AGREEMENT FOR THE OPERATIONS, MANAGEMENT, AND MAINTENANCE OF WATER
TREATMENT FACILITIES, WELL FIELD, AND STORAGE TANKS BETWEEN THE CITY
OF VICKSBURG, MISSISSIPPI AND INRAMARK, LLC d/b/a ESG OPERATIONS**

WHEREAS, the City of Vicksburg, Mississippi ("City") entered into a services agreement with Inframark, LLC d/b/a ESG Operations on July 8, 2016, for the operations, management, and maintenance of water treatment facilities, well field, and storage tanks; and

WHEREAS, under Exhibit C, Part 2, of said Agreement, all parties agreed as follows: "As of July 5th of Contract Year 2, and as of each July 5th of each subsequent Contract Year, the Annual Fee shall be adjusted from Base Annual Fee by Consumer Price Index ("CPI") for All Urban Consumers (U.S. City Average) as published by the U.S. Department of Labor, Bureau of Labor Statistics for April of corresponding Contract Year. The Base Annual Fee will not be reduced due to the CPI adjustment"; and

WHEREAS, on November 21, 2022, Amendment No. 1 to the Services Agreement between ESG and the City was executed, but did not revise or amend the above referenced provision; and

WHEREAS, July 5, 2026, is the beginning date of Contract Year 11 of the services agreement, and the CPI increase is 3.8%; thus, resulting in a contract increase of Thirty-Seven Thousand, One Hundred and Sixty-Three Dollars and Thirty-Nine Cents (\$37,163.39) to the Base Annual Fee.

NOW, THEREFORE, BE IT RESOLVED, by The Board of Mayor and Aldermen of the City of Vicksburg, Mississippi that the Base Annual Fee of the Services Agreement for the Operations, Management, and Maintenance of Water Treatment Plant Facilities between the City of Vicksburg, Mississippi and Inframark, LLC d/b/a ESG Operations, be increased by 3.8% based upon the CPI in an amount of Thirty-Seven Thousand, One Hundred and Sixty-Three Dollars and Thirty-Nine Cents (\$37,163.39), as stipulated and agreed to by the parties in said Agreement, effective July 5, 2026.
