

**RESOLUTION AUTHORIZING THE CITY OF VICKSBURG  
WARD 1 COMMUNITY CLEAN UP DAY**

**WHEREAS**, pursuant to Mississippi Code Annotated Section 21-19-1, the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi (“Board”) is authorized to make regulations to secure the general health of the city; and

**WHEREAS**, the Board will sponsor a Community Clean Up Day in Ward 1 on Saturday, April 18, 2026 for citizens in Ward 1 to dispose of trash at three (3) designated locations that being Vicksburg Junior High School located at 1533 Baldwin Ferry Road, Vicksburg, Mississippi 39180, Triumphant Church (Kings) located at 224 RL Chase Circle, Vicksburg, Mississippi 39180, and Stanfield New Life Church located at 1404 Lane Street, Vicksburg, Mississippi 39180; and

**WHEREAS**, Ward 1 Alderman Thomas J. Mayfield will obtain two (2) quotes for garbage dumpsters for the disposal of trash for Ward 1 citizens to secure the general health of the city; and

**WHEREAS**, the Board requests that any citizen desiring to participate please contact Ward 1 Alderman Thomas J. Mayfield to sign up and sign a waiver to clean any city owned or managed properties.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**

**SECTION 1.** That the Board of Mayor and Aldermen of the City of Vicksburg hereby adopts the forgoing recitals as its findings.

**SECTION 2.** That the Board hereby approves Saturday, April 18, 2026 as a designed Community Clean Up Day in Ward 1 where citizens are encouraged to 1) pick up trash and debris and dispose in garbage dumpsters; 2) donate time, services, resources and equipment to cut grass

and/or weed eat city owned property(ies) or 3) donate time, services, resources and equipment to cut trees on city owned-property(ies);

**SECTION 3.** That the Board hereby approves the Community Clean up Day in Ward 1 to allow citizens to unite to foster a sense of community and pride by making a difference in the City of Vicksburg.

**SECTION 4.** That the Board hereby authorizes the receipt of two (2) quotes for the garbage disposal dumpsters to dispose of collected trash and debris.

**SECTION 5:** That anyone who desires to volunteer should contact Ward 1 Alderman Thomas J. Mayfield to sign up and to sign the Waiver for participation.
