I give my Executor absolute authority and discretion to determine how to apply, pay over, and distribute these funds to benefit the Senior Citizen Center in Vicksburg, Mississippi. Should Andrew Vernon Brown predecease me, I give, devise, and bequeath his share to my daughter in law, Teresa Brown.

Should both Andrew Vernon Brown and Teresa Brown predecease me, I give, devise, and bequeath Andrew's share to Alex Brown.

Should Barbara Jo Smith predecease me, I give, devise and bequeath her share to Cameron Smith.

ITEM FIVE: I hereby nominate, constitute and appoint my son, Stephen Doyle Brown, as Executor of this my Last Will and Testament and direct that as Executor he shall not be required to give any bond, nor to render any account, inventory or report to any Court as such Executor and he shall have all powers granted Trustees under Title 91, Chapter 8, Article 8 of Miss. Code Ann. (1972) as same may be amended from time to time and in addition thereto shall have full power to sell at public or private sale any and all real or personal property without Court approval.

In the event my son, Stephen Doyle Brown, should be unable or unwilling to serve as Executor of my Last Will and Testament, then I hereby appoint my son, Andrew Vernon Brown, as Executor in his stead, and he shall have all powers and discretion heretofore granted my Executor and he shall not be required to give any bond, nor to render any account, inventory or report to any Court as Executor.
