

**RESOLUTION AUTHORIZING ITG COMPLIANCE OFFICER TRACY WOLD AS THE CITY
OF VICKSBURG'S AUTHORIZED REPRESENTATIVE FOR AMBULANCE SERVICE
PROVIDER ENROLLMENT, CREDENTIALING AND REVALIDATION**

WHEREAS, the City of Vicksburg, Mississippi (hereinafter "City") owns, operates and maintains ambulance service to provide Emergency Management Services (hereinafter "EMS") through the Vicksburg Fire Department, for the citizens of the City of Vicksburg, Mississippi; and

WHEREAS, on January 10, 2023, the City entered into a Client Services Agreement with ITG Strategies, LLC (hereinafter "ITG") for ITG to prepare and submit the ambulance data cost report needed for the Centers for Medicaid & Medicare Services ("CMS"); and

WHEREAS, as an EMS provider, the ambulance service must maintain compliance with CMS to ensure continued reimbursement through revalidation, enrollment and credentialing. Revalidation is the process by which EMS providers update and reconfirm their enrollment with CMS to retain their billing privileges. Credentialing is the process by which EMS providers verify that their paramedics and EMTs have active, unblemished licenses. Enrollment is the process where an EMS provider enrolls as a Mississippi fee-for-service or other contracted provider for CMS;

WHEREAS, the City seeks to appoint a representative to process data and submit information needed to CMS for the City to comply with federal laws and rules relating to retain billing privileges.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Mayor and Aldermen of the City of Vicksburg hereby authorizes and directs Tracy Wold of ITG Strategies, LLC to prepare forms needed, review documents provided by CMS or Blue Cross Blue Shield, submit documents authorized by the Board of Mayor and Aldermen of the City of Vicksburg to CMS or Blue Cross Blue Shield needed to ensure continued reimbursement of payments through the revalidation, enrollment and credentialing processes, and act on behalf of the City in ensuring that the City complies with CMS or Blue Cross Blue Shield and serve as the Point of Contact on behalf of the City with Mississippi Division of Medicaid, Blue Cross Blue Shield and CMS in consultation with the Vicksburg Fire Department.
