

**A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF
VICKSBURG, MISSISSIPPI, AUTHORIZING THE RETENTION OF THE BADGE

WHEREAS, Mississippi Code Annotated Section 45-1-71, authorizes the Board to allow Melvin Doug Holman to retain his issued badge.

THEREFORE, IT IS NOW RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF VICKSBURG, MISSISSIPPI, AS FOLLOWS:
