

**RESOLUTION TO DECLARE PROPERTY SURPLUS AND AUTHORIZE SALE TO THE
VICKSBURG WARREN SCHOOL DISTRICT**

WHEREAS, on May 4, 2026, the Board of Mayor and Aldermen of the City of Vicksburg (“Board”) declared a 2003 STERLING LT9500 WITH VIN #FWJAZCVX3AM02419 (“vehicle”) as surplus property and authorized the City’s Purchasing Director to sell this vehicle at an auction held by Jeff Martin Auctioneers; and

WHEREAS, this determination was based on the following: that the vehicle is no longer of any value to the City, does not serve a useful function and is not required for the continued effective operation of the business of the City; and

WHEREAS, the Vicksburg Warren School District (“VWSD”) desires to purchase the vehicle for use with the CDL training program and approved a cost of \$8,000.00 to purchase said vehicle, see VWSD Purchase Order attached hereto as Exhibit A; and

WHEREAS, the Board of Mayor and Aldermen is of the opinion that the 2003 STERLING LT9500 WITH VIN #FWJAZCVX3AM02419 should be still declared as surplus property and sold to the VWSD for \$8,000.00 which is in the best interests of the City of Vicksburg; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. That the Board hereby adopts the forgoing recitals as its findings.

SECTION 2. That the 2003 STERLING LT9500 WITH VIN #FWJAZCVX3AM02419 previously declared as surplus property on May 4, 2026, should be sold to the Vicksburg Warren School District for \$8,000.00 since said vehicle is of no value to the City, and is no longer needed for the effective functioning of the City and conduct of City business.

SECTION 3. That the 2003 STERLING LT9500 WITH VIN #FWJAZCVX3AM02419 should be removed from the City’s inventory of assets and disposed of by selling to Vicksburg Warren School District and that Mayor Willis Thompson is authorized to sign all needed documents to effectuate the sale of the vehicle and transfer the title to the Vicksburg Warren School District.
