Dear Mayor Flaggs & City Council Members,

I am excited to announce the 2025 Mississippi Firefighter's Association Annual Conference, which will once again be held in the "Red Carpet City" of Vicksburg. This event is one of the most attended and sought after by first responders in our state and brings significant economic benefits to the host city.

As far back as 2017, Vicksburg has generously provided financial support of \$8,500 and up for our conferences. We appreciate this past support and kindly request consideration for similar support in 2025, as it significantly boosts the local economy and tourism.

For reference, the 2019 conference featured over fifty-five exhibitor/vendor booths, approximately two hundred vendor representatives, and 592 MFFA attendees plus guests. This resulted in a substantial number of hotel reservations and dining experiences, totaling over 430 hotel nights. The total estimated economic impact was well over \$500,000.

Furthermore, with the historical numbers we have from 2021 even after the effects of COVID on society, bringing 437 visitors plus vendors and guests. In 2022, we brought 545 members plus vendors and guests to your wonderful city, and hotel rooms were filled all over Vicksburg.
