# RESOLUTION AUTHORIZING BOARD OF MAYOR AND ALDERMEN OF THE CITY OF VICKSBURG TO ACQUIRE, BY DONATION FROM DELL P. ROGERS CERTAIN REAL PROPERTY LOCATED WITHIN THE CITY TO IMPROVE SUMMIT RIDGE DRIVE AND FOR THE IMPROVEMENT OF ANY OTHER INFRASTRUCTURE

WHEREAS, the Board of Mayor and Aldermen of the City of Vicksburg (the "Governing Body") of the City of Vicksburg, Mississippi (the "City"), acting for and on behalf of the City, hereby finds and determines as follows:

- 1. The Summit Ridge Development was developed outside of the city limits of Vicksburg in the 1970s and 1980s located off Katherine Drive.
- 2. In October of 1985, the Governing Body adopted Ordinance #85-13 which expanded the city limits and provided that the City would make the following improvements to the annexed areas which included grading, draining and improving existing streets, installing water lines, fire hydrants, sewer lines and street lighting and providing municipal services.
- 3. On or about April 7, 1988, Summit Ridge Drive was adopted as a public road.
- 4. The City installed water lines and appurtenances to the Summit Ridge Development on the north side of Summit Ridge Drive and under a portion of Chelsea Lane.
- 5. On May 19, 2025, the Governing Body adopted a Resolution for the City to make additional improvements to the Summit Ridge Development to include grading, draining and improving existing streets and installing sewer lines and street lighting. Pursuant to said adopted Resolution, residents of Summit Ridge Development were to donate a right of way for the construction of a roadway platted by Allen and Hoshall Engineering services with the intent of the roadway being approximately 20 feet wide thereby making two (2) 10 feet lanes.
- 6. The City is in need of acquiring the donation from Dell P. Rogers for the construction of a roadway platted by Allen and Hoshall Engineering services
- 7. Furthermore, Dell P. Rogers desires for her property to be donated to the City and has executed a Quit Claim Deed to formalize her desire, see Quit Claim Deed attached as Exhibit A.
- 8. Pursuant to Mississippi Code Annotated Section 21-17-1, the City is authorized to acquire real property.
- 9. The City, in anticipation of said donation, is willing to accept the donation of the property described in the attached deed with the following conditions:
  - a. The property will be donated to the City at no cost to the taxpayers of the City;

- The City will utilize the donated property for the improvement/construction of a roadway to be platted by Allen and Hoshall Engineering services;
- c. Dell P. Rogers warrants that she has the authority to donate the property as described in the attached Exhibit A; and
- d. The City will be responsible for the recording of the Quit Claim Deed.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY, AS FOLLOWS:

SECTION 1: That the Governing Body of the City will accept the donation of the aforementioned property from Dell P. Rogers.

SECTION 2: That the Governing Body of the City authorizes the City of Vicksburg Legal Department to record the Quit Claim Deed executed by Dell P. Rogers at the Warren County Chancery Clerk's Office.
