Dear Charles:

Suncoast Infrastructure, Inc. is requesting a time extension for the referenced project. The following represents the justifications for the time extension:

1. The date of completion for the project was established in the contract documents prior to the bid opening. Any delays between the bid opening and the actual award and execution of the Agreement between the Owner and the Contractor would significantly impact the amount of time allowed to complete the project.

2. After the opening of the bids for the project, an official protest of the bid was filed by another bidder. The procedures for handling the protest caused a delay in the Contract by 30 days.

3. During the course of the work, Suncoast has encountered an excessive amount of debris in the lines which required "Heavy Cleaning". Currently, we have exceeded the plan quantities for "Heavy Cleaning" by nearly 300%. This extra effort has decreased our production rates considerably, essentially slowing the progress of our work.

4. Due to some of the inaccuracies with the Contract Plans, we have expensed considerable man-hours to locate the manholes, determine the actually layouts of the sewer lines and accomplish the goal of the project. Essentially, delay the progress of our work.

With these items being the case, Suncoast began work on the project nearly a month prior to receiving the executed Agreement for the project. Suncoast has had numerous crews on the project concurrently for the full length of the contract. From the beginning, we knew the time constraints of the project and put forth the greatest effort to accomplish the goal of the project and to complete the work on time. Suncoast feels justified in requesting a time extension of 42 days for this project.
