How to Renew your USA Softball Team Insurance:

1. MAIL THIS RENEWAL INVOICE, along with your check payable to "RPS Bollinger" in the enclosed, self-addressed envelope.
2. OR, FOR IMMEDIATE SERVICE, contact your USA Softball commissioner for a user ID and password, then, renew on-line through our web site at www.RPSBollinger.com. Upon verification of your credit card, you will be able to create and print the certificates of insurance directly from your

Renewal Information Packets:

- For on-line orders, you may print your certificates and claim forms directly from your computer. Or if you prefer, you may request that RPS Bollinger mail them to you (they will be sent out within two business days).
- For mail-in orders, your certificates and claim forms will be processed and mailed out to you within two business days from the date we receive the mail-in order and payment.

PLEASE NOTE: Mail-in orders can take up to a week or longer to get to our office. Please allow adequate time to process your insurance packet.

RUSH SERVICE: If you need expedited same-day service, or if you need your certificate(s) faxed or emailed to you or to the field owner, there is a \$25 Processing Fee.

Number of Teams

The renewal calculation is based on the number of teams insured in 2016. If the number of teams has changed, please recalculate and remit the corrected amount. If adding or changing teams, please include separate sheet listing team names and age grouping for each team, along with top portion of this form.

League Rate vs. Single Team Rate

To qualify for the league rate, payment for at least four teams must be submitted with your renewal. If you insured four or more teams in 2016, and will be insuring less than four in 2017, please see enclosed application for single team rates.

Age Group

The insurance youth premium is based on two age categories, 12 & Under and 13 to 19. For example if your team is 16 & Under, they fall under the 13 to 19 age category; if your team is 10 & Under, they fall under the 12 & Under age category. If your team was 12 & Under in 2016 and changing to 13 to 19 in 2017, please see enclosed application for appropriate age group premium. Please note, if there are both 12 and 13 year old players on your team, the 13 to 19 age group premium applies.

Team Name & Additional Insured Changes

If team names and/or additional insured names will change for 2017, please indicate changes on separate sheet and include with the top portion of this form. Please be sure to include age grouping with new team names.

Certificates of Insurance

Please allow two weeks for processing your certificates of insurance. Same-day rush is available for an additional fee of \$25.
