Add: \$ 245.00

Item 4. Change the 1 hour fire wall roof detail to the detail shown on drawing SA-05.

Add: \$4,752.00

Item 5. Change the 1/2 hour fire walls that separate bed rooms to non-fire-rated walls.

Deduct: (\$ 2,788.00)

Total Deduct this Change Order: \$4,967.00
