REVISED RESOLUTION GRANTING CONDITIONAL APPROVAL FOR TAX ABATEMENT FOR 717 GROVE STREET (PPIN 019187)

NOW, THEREFORE BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Vicksburg, that the application for tax abatement submitted by Michelle Lay for and on behalf of Dale Ray Jennings, owner for 717 Grove Street (PPIN 019187) is conditionally approved contingent upon (1) all work being performed in accordance with the Certificate of Appropriateness issued by the Board of Architectural Review; (2) that the increase in ad valorem taxes for a period not to exceed seven (7) years shall be abated contingent upon the work being performed in accordance with any Certificates of Appropriateness and all other city codes and ordinances; (3) upon final inspection, the City will submit necessary information to the Warren County Tax Assessor for a final determination in accordance with the Tax Abatement Program; (4) that the revised project completion date will be on or before May 31, 2018 unless otherwise extended by the Board of Mayor and Aldermen.
