WHEREAS, at a previous hearing the governing authorities of the City of Vicksburg adjudicated the condition of a parcel of property located at 1114 Second North St, PPIN 18816 Vicksburg, Mississippi, owned by Freddie Parson in its then condition to be a menace to the public health and safety of the community.

WHEREAS, the governing authorities, after the owner failed to do so himself, proceeded to have the land cleaned as provided by law.

WHEREAS, the actual cost of cleaning said property is Three Hundred Thirteen Dollars and 75/100 (\$313.75).

WHEREAS, that cost may become an assessment against the property in accordance with law.

NOW, THEREFORE, be it resolved that the governing authority pursuant to 21-19-11 of the Miss. Code Ann. Of 1972 as Amended do hereby adjudicate the actual cost of cleaning the property located at 1114 Second North St, PPIN 18816 Vicksburg, Mississippi owned by Freddie Parson to be Three Hundred Thirteen Dollars and 75/100 (\$313.75).
