MISSISSIPPI:


RE: PETITION TO CLOSE AND VACATE A PORTION OF RIVERWOOD PLACE IN THE
CITY OF VICKSBURG, MISSISSIPPI.

The undersigned Paul and Donna Ingram and Rodney E. Bounds petition that the certain section of Riverwood Place depicted in Exhibit "A" attached hereto, be VACATED AND CLOSED in accordance with the laws of the State of Mississippi.

Said petitioners own the land adjoining the portion of Riverwood Place to be closed and vacated on both the east and west sides thereof. Petitioners further show that said section of Riverwood Place does not continue as a through street and that same will never be used for such street purposes and that its closure would not affect the public's use and enjoyment of any other streets in the City of Vicksburg. In addition, there are no other property owners with property adjacent to said street section, the Petitioners are the only property owners adjoining and affected by said street section.

NOW, THEREFORE, the Petitioners request that the Board of Mayor and Aldermen of the City of Vicksburg, Mississippi, adopt the appropriate ordinance according to law vacating and closing the street or roadway hereinabove described and to execute and deliver to Petitioners quitclaim deeds to the lands comprising same so that same may be returned to the Ad Valorem Tax Rolls of Vicksburg, Warren County, Mississippi, subject to the rights of the City of Vicksburg for the continued location and maintenance of any water, gas, sewer or other utility lines which are presently found therein.



EXHIBIT A

BEGINNING at the northeast corner of Lot 23 of Dabneys Residential Subdivision as shown in Deed Book 270 at Page 328 of the Land Records of Warren County, Mississippi, such point being on the west right-of-way of Riverwood Place, thence run easterly a distance of 33' to a point on the east right-of-way of Riverwood Place, said point also being the northwest corner of Lot 24 of said Dabneys Residential Subdivision, run thence S 2 degrees 56 minutes east along said east right-of-way of Riverwood Place at distance of 78' to a point, thence run in a westerly direction 33' to a point on the west right-of-way of Riverwood Place, said point being 78' south of the point of beginning, thence run along said west right-of-way of Riverwood Place N 2 degrees 56 minutes W a distance of 78' to the point of beginning, all situated in the City of Vicksburg, Warren County, Mississippi.
