On behalf of the City of Vicksburg, I am writing to provide an update on the aforementioned project and request your consideration of a project extension due to unforeseen conditions.

As a result of approved weather delays and unforeseen need to order a control panel, the City is requesting an additional 75 days to complete the project. The City's engineer is in agreement with the City's contractor's request for 21 additional days as a result weather. Furthermore, the contractor and city employees have been unable to locate a control panel for the clarifier; therefore, a new panel must be ordered from the manufacturer. The panel will take an estimated 54 days to produce and ship to the site. The City's engineer has prepared a probable timeline for completion of the construction, which is listed below.
