Fat-to-Fit Family Membership Agreement

WHEREAS, Fayette Community Service Organization (hereinafter referred to as FCSO), a Community Based Organization (CBO), whose physical address is 1453 Main St., Fayette, Mississippi 39069 is the creator and organizer of the Fat-to-Fit Family for promoting health and wellness.

(hereinafter referred to as "the member") hereby undertakes to join the Fat-to-Fit Family of the Fayette Community Service Organization and collaborate to promote health in its area through common activities and events and organize with FCSO; and engage in health and healthy lifestyle activities for all.

The activities include but are not limited to:

1. Health Screenings
2. Health promotion education
3. Community engagement activities including organizing health promoting clubs and organizations
4. Recruitment of people to engage in FCSO required activities
5. Recruitment of people to engage in jointly designed activities
6. Joint activities, including the Fat-to-Fit Olympics organized by FCSO

For jointly designed activities, the organization agrees to share ideas, resources and efforts through a planning committee, which will approve of such ideas and resources to be incorporated in the joint activities.

The organization, in committing to the agreement, agrees to submit to FCSO assessment of readiness and capacity, to determine if the Organization is able to engage in the Fat-to-Fit Family procedures, processes and activities. Pending qualification, provided by FCSO, the Organization shall have an Interim Member Status.

In case the member is adjudged needing preparation, FCSO and their consultants shall work with the member to prepare and be qualified to be a Full member of the Fat-to-Fit Family.

The Organization, in committing to this agreement, shall meet from time to time to review progress and address issues of interest and concern for the Fat-to-Fit-Family.

If any disagreements or disputes shall occur, the parties shall present to the Fat-to-Fit Family Joint Arbitration Committee to arbitrate and resolve any differences and concerns. For this purpose, no party shall refuse to participate in arbitration. The decisions of the Joint Arbitration Committee thus formed shall be binding on all parties. If all parties find to have reached an impasse in negotiation the option to terminate this agreement within 30 days providing written notice shall be accepted.

The term of this agreement shall be for an initial period of three (3) calendar years beginning on the date of the last signature to this understanding/agreement; after which the agreeing parties shall renew the agreement as every five years.

None Disclosure

The member will not, except as authorized and/or required by the members duties (for example, government official/entity, etc.), reveal or divulge to any person or entity any information concerning the organization, business, finances, transactions or other affairs of FCSO and the Fat-to-Fit-Family or of any of FCSO and the Fat-to-Fit-Family's respective subsidiaries which may come to the member's knowledge during the continuance of this agreement, and the member will keep in complete secrecy all confidential information entrusted to the member and will not use or attempt to use any such information in any manner which may injure or cause loss either directly or indirectly to FCSO and the Fat-to-Fit-Family's interests. This restriction will continue to apply after the termination of this agreement without limit in point of time but will cease to apply to information or knowledge which may come into the public domain.
