RE: Permission to hold Walk for Life Event

On behalf of The Center for Pregnancy Choices, I am requesting permission to hold our Walk for Life Event on Saturday, April 14th from 9:00 A.M. - 11:00 A.M.

The Walk for Life Event is a one-mile walk, in conjunction with a family friendly celebration to raise money for the Center. The one mile walk course will start and end beside the Center for Pregnancy Choices on Crawford Street. We would like City's permission to use streets for this walk as this constitutes a significant portion of our Center's funding for the year. We would also like to request police assistance on route, the day of the walk. The Center for Pregnancy Choices is completely community and fundraiser funded. We would like to make this a community event to both increase the fundraiser's capacity and to ensure families in our community are aware of the Center and the services we provide.

The route for the one mile walk would start at the intersection of Crawford and Adams, go west on Crawford to Walnut, turn south on Walnut to Veto, turn west on Veto to Washington, turn south on Washington to Madison, turn east on Madison to Monroe, turn North on Monroe to Crawford, turn east on Crawford and finish back at Crawford and Adams. We would like to request the assistance of the Vicksburg Police Department for traffic assistance at the corners of South/Monroe and Cherry/Crawford and possibly the corner of Monroe/S. Madison. The one mile walk would last from 9:00 A.M. - 10:00 A.M.; we would only require police assistance from 8:45 A.M. - 10:15 A.M. We would like to request blockading Crawford from Cherry Street to the Dead End and blockading Adams Street from Clay Street to South Street for the entire duration of the event, from 8:30 A.M. - 11:30 A.M.


Lastly, as a non-profit providing free services for the betterment and prosperity of the community at large we would humbly request you waive any fees typically associated with this level of police and city assistance.
