2018 AWARD LETTER

We are dumbfounded at the national, state and local decrease in charitable giving, as it is very apparent that the need continues to remain. We have all been called to be the champion for the forgotten, but we are asked to provide such services with limited resources. It is with a very heavy heart that we are tasked with sharing the outcome of our 2017 Campaign that fell short \$142,000 in comparison to last year's Campaign. This drastic reduction in Campaign dollars will be felt in our community. It will be felt by those being served and those who serve. In attempt to minimize the reductions in allocations to our partner agencies, United Way has taken steps to reduce our administrative cost by reducing staff and other administrative expenses. The United Way of West Central Mississippi will still be collecting funds until February 28, 2018; therefore, there will be a slight increase in your allocations that will be reported to you on March 1, 2018.
