

**ORDINANCE 2018-\_\_\_\_\_**

**AN ORDINANCE TO AMEND ORDINANCE 71-8, AS AMENDED, THE ZONING  
ORDINANCE OF THE CITY OF VICKSBURG, MISSISSIPPI BY  
REZONING A CERTAIN AREA OF LAND WITHIN THE LIMITS  
OF THE CITY OF VICKSBURG, MISSISSIPPI, AND TO AMEND THE  
OFFICIAL ZONING MAP OF THE CITY OF VICKSBURG, MISSISSIPPI**

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF  
VICKSBURG, MISSISSIPPI as follows:

SECTION ONE: That the zoning ordinance of the City of Vicksburg, Mississippi, Ordinance  
71-8, of the Code of Ordinance, as amended, be amended by rezoning properties at 169  
Magnolia Road (PPIN 11563) from the present use and classification of C-PUD to L-2 Heavy,  
3577 Hwy 61 South (PPIN 27013) from the present use of classification of C-PUD to MX-1  
Mixed Use Residential, and PPIN 11565, PPIN 11310 and PPIN 11335 from the present use of  
classification of C-PUD to L-2 Heavy Industrial.

SECTION TWO: That the official zoning map of the City of Vicksburg, Mississippi be and the  
same is hereby changed, altered and amended to correctly show as part thereof the above  
described land area, as hereinabove rezoned by the Mayor and Aldermen of the City of  
Vicksburg, Mississippi.
