WHEREAS, the programs offered by the RAINBOW FARMS, MS THERAPEUTIC RIDING CENTER FOR THE HANDICAPPED are a social and community services programs described in Section 21-19-65 of the Mississippi Code of 1972, as amended, and are therefore eligible for matching funds in support of the programs by the City of Vicksburg; and

WHEREAS, the City of Vicksburg finds that it would be beneficial to provide matching funds in the amount of \$800.00 to assist the RAINBOW FARMS, MS THERAPEUTIC RIDING CENTER FOR THE HANDICAPPED with its programs for the handicapped and disabled; and,

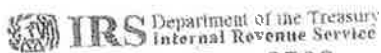
