

ORDINANCE 2018-_____

**AN ORDINANCE TO AMEND ORDINANCE 71-8, AS AMENDED, THE ZONING
ORDINANCE OF THE CITY OF VICKSBURG, MISSISSIPPI BY AMENDING
SECTIONS 406.4-2, 406.9-1.1 AND 406.10-2(11) BY ADDING A PROVISION TO
ALLOW ANY USE SELLING LIGHT WINE, BEER AND/OR ALCOHOLIC
BEVERAGES IN THE LEISURE AND RECREATION DISTRICT, OTHER THAN A
FULL SERVICE RESTAURANT,
TO BE PERMITTED AS A SPECIAL EXCEPTION**

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF
VICKSBURG, MISSISSIPPI as follows:

SECTION ONE: The following language shall be added in Section 406.4-2:

(5) Leisure and Recreation District Uses permitted by Special Exception. See Code of Ordinances, Chapter 3, Section 3-15 for the boundary of the Vicksburg Leisure and Recreation District.

1. Small Craft Brewery and Brew Pubs.
2. Any use selling light wine, beer and/or alcoholic beverages in the leisure and recreation district, other than a full service restaurant;

SECTION TWO: The following language shall be added in Section 406.9-1.1:

(c) Leisure and Recreation District Uses permitted by Special Exception. See Code of Ordinances, Chapter 3, Section 3-15 for the boundary of the Vicksburg Leisure and Recreation District.

1. Small Craft Brewery and Brew Pubs.
2. Any use selling light wine, beer and/or alcoholic beverages in the leisure and recreation district, other than a full service restaurant;

SECTION THREE: The following language shall be added in Section 406.10-2(11):

(11) Leisure and Recreation District Uses permitted by Special Exception. See Code of Ordinances, Chapter 3, Section 3-15 for the boundary of the Vicksburg Leisure and Recreation District.

1. Small Craft Brewery and Brew Pubs.
2. Any use selling light wine, beer and/or alcoholic beverages in the leisure and recreation district, other than a full service restaurant.
