This Irrevocable Direction is irrevocable and unconditional unless Owner receives a claim for funds from the Surety, in which case Owner is authorized and directed to honor such claim and terminate this Irrevocable Direction by written notice to Manager, accompanied by a copy of the Surety's claim notice.
- 5. Contractor agrees that this Irrevocable Direction does not supersede any rights the Owner may have to withhold payments or portions of payments granted under the Contract.
- The Owner has no obligation or responsibility under this Irrevocable Direction other than to send payment of Contract Funds to <u>Syrberus</u>, <u>Inc.</u>, <u>4164 Austin Bluffs Parkway</u>, <u>Suite 362</u>, <u>Colorado Springs</u>, <u>CO 80918</u>.
