

**ADDENDUM TO HEALTH SERVICES AGREEMENT BETWEEN
SOUTHERN HEALTH NETWORK, INC. AND
THE CITY OF VICKSBURG, MISSISSIPPI**

THIS ADDENDUM to the Health Services Agreement, dated as of February 8, 2019 (“Addendum”), is made and entered into by and between the City of Vicksburg, Mississippi (“COV”), and Southern Health Network, Inc., d/b/a Vigilant Health (hereinafter referred to as “Vigilant”).

RECITALS

WHEREAS, COV and Vigilant have entered into that certain Health Services Agreement, dated July 25, 2016 (the “Agreement”), pursuant to which Vigilant provides certain services, as described therein, on behalf of the employees and dependents who receive coverage under COV’s health benefits plan (the “Health Plan”);

WHEREAS, COV desires to engage Vigilant to administer vaccinations and related services to certain employees of COV and others as determined from time to time by COV, as set forth in Appendix I to this Addendum, a copy of which is attached and fully incorporated by this reference (the “Vaccination Program”); and

WHEREAS, the Vaccination Program will be provided and administered by Vigilant for the account of the City of Vicksburg and paid directly by COV and not as part of its Health Plan or as a benefit under the Agreement.

DEFINITIONS

All terms not otherwise defined in this Addendum shall have the same meaning as set forth in the Agreement.

AGREEMENT

1. COV and Vigilant hereby agree that Vigilant will provide the Vaccination Program as as set forth in Appendix I of this Addendum. Except with respect to the obligations of Vigilant to provide, and the obligations of COV to pay for, the Vaccination Program separate from the Health Plan, in the event of any conflict or inconsistency between the terms and conditions of this Addendum and the terms and conditions set forth in the Agreement, the provisions of the Agreement will govern the rights and obligations of the parties.

2. Except as otherwise expressly provided in this Addendum, all of the terms and conditions of the Agreement are, and will remain, in full force and effect.

IN WITNESS WHEREOF, the undersigned parties hereby agree to this Agreement as of the date set forth above.

Appendix I

Vaccination Program

Program	Vigilant Health will administer vaccinations to Employees of the City of Vicksburg in the Clinic.
Eligibility	Employees of the City of Vicksburg who are requested or advised to have these vaccinations due to potential exposure to infectious diseases as part of their jobs
Operation	<p>The City of Vicksburg will identify employees requiring certain vaccinations required for employee health and refer these employees to the Vigilant Health Clinic in Vicksburg for the particular vaccinations to be administered. Vaccinations to include Hepatitis B, TB Skin Test, and Tetanus.</p> <p>The City of Vicksburg will organize and coordinate the required consent forms, including providing the Vigilant Health Clinic with a copy by fax or e-mail, for each employee prior to receiving vaccinations. The City of Vicksburg will communicate with the Vigilant Clinic the vaccinations needed.</p> <p>The Vigilant Health Clinic will capture in its Electronic Health Record the visit and CPT Code for each vaccination administered. The Clinic will provide a report to City of Vicksburg of individuals and the vaccinations received monthly and a document for each individual vaccinated for his or her personnel file.</p>
Start-up Expenses	Upon approval of this Proposal, the City of Vicksburg will pay Vigilant Health an amount equal to \$580 as a partial offset of the administrative and start-up costs in designing, developing, and implementing the Program. Projected time for development is 5 hours.
Program Administration	The City of Vicksburg will pay Vigilant Health \$232 per month, at the beginning of each month, to administer the vaccinations to all employees referred by the City of Vicksburg, run monthly reports, and the addition of new patients not currently in EMR. Projected time is 2 hours per month.
Vaccinations	<p>The cost of each vaccination will be passed through at cost to the City of Vicksburg, for payment monthly to Vigilant Health. Prices are subject to vendor and are currently:</p> <ul style="list-style-type: none">○ Hepatitis B - \$57.85○ TB Skin Test - \$10.33○ Tetanus - \$40.48
